I am writing in response to the letter you sent to Judge Welsh on March 7, 2024 (the "March 7th Letter") regarding the proposed settlement reached in *Finn et al., v. Empress Ambulance Service, LLC* (the "Settlement").

First and foremost, we would like to apologize for any difficulties you encountered in getting the information you requested. The intention of the notice process is to be as transparent and user friendly as possible and we apologize that was not your experience.

We have now looked into the matters you raised and are hopeful we can address your concerns and provide the information you seek.

- 1. We have researched the issue you raised regarding the dedicated email address. You are correct that there was a glitch in the system that caused emails to bounce back. We are grateful that you followed up with a mailed letter and brought this to our attention. We can assure you that it has been corrected.
- 2. In response to your question as to what pieces of your information were in Empress's system and why, Empress searched its systems for your name and located the following information:

> we provided to you in our initial notice of the incident and the same information the Administrator informed you about in its correspondence. If you do not believe this information is accurate, please let us know. Assuming that is you, we are happy to honor a request to delete your information to allay any future concerns you may have.

Lastly, we, along with Plaintiffs' counsel, would like to schedule a call with you regarding any outstanding concerns you may still have related to the Settlement. We believe the Settlement provides tremendous value to anyone who has potentially been affected by the Incident. For example, if you submitted a claim for a cash fund payment you would receive roughly \$134 in addition to the one year of three credit bureau monitoring and \$1 million in identity theft insurance offered.
